## NOTIFICATION

In pursuance to the EOI No. 3060 dated. 05.12.2022 an Expression of Interest was invited from the Mission Shakti Self Help Group for the management of ward offices in all 12 wards under Binka NAC during the year 2023-24. The H&UD Department vide the letter No. 2268 Dated. 01.02.2023 has been decided to further extend the last date for receipt of EOI application from 31<sup>st</sup> January 2023 to 10<sup>th</sup> February 2023. As per the revised time lines the sealed expression of interest should be received by this office on or before 10.02.2023, 5.00PM by registered/ speed post only.

The technical bid will be opened on 13.02.2023 at 11.30 AM in the office chamber of EO, NAC Binka . The applicant should write "EOI for Management of Ward Offices by Mission Shakti SHGs, 2023-2024" at the top of the envelop. The detailed revised terms and conditions vide letter no. 2245/HUD Dept. Govt. of Odisha Dated. 31.01.2023 for applying are as follows:


1. MSG should be from the same ward (in the absence of an eligible group, the MSG from the nearby ward may be considered with the committee's approval).
2. MSG must be at least one (1) year old as on the date of application.
3. MSG must be strictly following the Panchasutra.
4. The minimum qualification of any member of the MSG should be matriculation.
5. MSG must have a Permanent Account Number (PAN).
6. MSG must have been previously engaged in income-generating activities.
7. MSG must not have records of financial irregularities (such as loans declared NPA and write-offs etc.).
8. MSG must not have a record of involvement in any anti-social or criminal activities
